*Orthopaedics & Traumatology: Surgery & Research (OTSR), and its French version Revue de Chirurgie Orthopédique et Traumatologique (RCOT)* publish *Original articles* on clinical or basic science research topics relevant to orthopaedics, *Case reports* relating to rare and illustrative observations, *Technical notes* presenting innovations in the use of exploration or evaluation materials, *Review articles*, and *Letters to the Editor* from readers on articles published in this journal. Articles are chosen for publication based on critical analysis by at least two expert reviewers and reported by an editor assigned to the submission.

*Official Publication of the Société Française de Chirurgie Orthopédique et Traumatologique* (French Society for Orthopaedic Surgery and Traumatology), the journal publishes one special issue each year to report research from the Société Française d'Arthroscopie (French Arthroscopy Society). One supplement to issue 1 is devoted to the SoFCOT instructional lectures. Basic science articles are published in the journal's English version (OTSR). The editorial board asserts the total independence of its choices and decisions with respect, among others, to the publisher, industry and more generally the commercial activities of the publication.

The journal agrees to use the "Uniform requirements for manuscripts submitted to biomedical journals" ([www.icmje.org](http://www.icmje.org)). It also adheres to the rules of the Committee on Publication Ethics (COPE) and the recommendations of the French Health Authority (Haute Autorité de la Santé: HAS).
