**Aims and scope.** *Schizophrenia Research* provides rapid publication of new international research that contributes to the understanding of schizophrenia and related disorders. The journal brings together previously separated biological, clinical and psychological research on this disorder, and stimulates the synthesis of clinical and research data into cohesive hypotheses.

**Types of papers.** (1) Full-length papers: 4000 words. (2) Short communications: 1000–1500 words. (3) Letters to the Editors: 600–800 words, 10 references, 1 figure or table. (4) Special solicited research and/or reviews. (5) Invited comments or hypotheses. (6) Editorials. (7) Schizophrenia meeting reviews: solicited and/or submitted. (8) Book reviews.

**Submission of manuscripts.** Submission to *Schizophrenia Research* proceeds totally online. To access the online submission system please visit <http://ees.elsevier.com/schres>.
